**Subject:- Fixation of Seniority of Mr. Kumar Abhishek & Mr. Liaqet Mehmood,
Accounts Officers.**

Government Order No. 142 -F of 2025
DATED 15.05.2025

Whereas, Mr. Kumar Abhishek and Mr. Liaqet Mehmood, were appointed as Accounts Officers in the J&K Accounts (G) Service vide Government Order No. 179-GAD of 2014 dated 12.02.2014, and Government Order No. 398-GAD of 2014 dated 05.04.2014 respectively.

Whereas, it was clearly stipulated in the aforementioned Government Orders that for the purpose of determining their seniority in terms of Rule 24 of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956, Mr. Kumar Abhishek and Mr. Liaqet Mehmood, shall be deemed to have been appointed to the Jammu and Kashmir Accounts (G) Service, notionally with effect from 18.09.2013, that is the date on which other candidates lower in merit in the select list were appointed to the said service vide Government Order No. 1350-GAD of 2013 dated 18.09.2013, read with Government Order No. 1446-GAD of 2013 dated 10.10.2013 and Government Order No. 179-GAD of 2014 dated 12.02.2014, with a condition that such notional appointment shall not confer any monetary benefit upon the said officers.

Whereas, while issuing Seniority of the Members of J&K Accounts (G) Service, Mr. Kumar Abhishek and Mr. Liaqet Mehmood, were placed at S.No. 297 & 298 in annexure "F" of Seniority list notified vide Government Order NO. 24-F of 2015 dated 04.02.2015, S.No. 297 & 298 in annexure "F" of Seniority list notified vide Government Order No. 19-F of 2016 dated 20.01.2016, S.No. 254 & 255 in annexure "E" of Seniority list notified vide Government Order NO. 63-F of 2018 dated 26.02.2018, S.No. 199 & 200 in annexure "E" of Seniority list notified vide Government Order NO. 164-F of 2019 dated 27.02.2019, S.No. 178 & 179 in annexure "E" of Seniority list notified vide Government Order NO. 18-F of 2020 dated 15.01.2020, S.No. 25 & 26 in annexure "F" of Seniority list notified vide Government Order NO. 138-FD of 2021 dated 26.04.2021, S.No. 22 & 23 respectively in annexure "F" of Seniority list notified vide Government Order No. 37-F of 2025 dated: 06.02.2025, S.No. 45 & 46 in annexure "E" of Seniority list notified vide Government Order No. 38-F of 2025 dated: 06.02.2025 and S.No. 35 & 36 in annexure "E" of Seniority list notified vide No. Government Order No. 39-F of 2025 dated: 06.02.2025, respectively.

Whereas, both the officers represented for re-fixing of their seniority notionally w.e.f 18.09.2013 i.e the date on which other candidates lower in merit in the select list were appointed to J&K Accounts (G) Service vide Government Order No. 1350-GAD of 2013 dated 18.09.2013 read with Government Order No.

1446-GAD of 2013 dated 10.10.2013 & Government Order No. 179-GAD of 2014 dated 12.02.2014.

Whereas, the case was examined in terms Rule 24 of J&K Civil Services (Classification, Control and Appeal) Rules, 1956 read with the appointment Orders of the officers.

Whereas, vide No. DGAT-CAE0P/F/32/2023-01(7177147)/230 dated 15.04.2025, a notice was issued calling upon the members of the service/cadre, who were likely to be affected by refixing the seniority of Mr.Kumar Abhishek and Mr. Liaqet Mehmood, at appropriate place in the seniority lists, to submit their objections, if any, along with documentary proof within a period of 07 days. However, no objection was received from any of the officers.

Now, therefore, the seniority of Mr.Kumar Abhishek and Mr. Liaqet Mehmood, is hereby re-fixed ab-initio in the Seniority lists issued from time to time, at appropriate places as under:-
