Consequent upon their appointment, the candidate(s) belonging to the Kashmir Division shall report to the Office of Chief Engineer, I&FC, Kashmir, and those belonging to the Jammu Division, shall report to the Office of Chief Engineer, I&FC, Jammu, within a period of twenty one (21) days from the date of issuance of this order. In case, any candidate(s) fails to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any notice. The final allocation of ranks and issuance of formal passing orders shall be made separately at a later stage.

The appointee(s) shall be allowed to join after the production of following certificates/documents (in original), to be verified separately: -

- I. Educational/Technical qualification (Degree/Diploma Certificates) issued by the recognized Institute / University.
- II. Matriculation/Date of Birth certificate.
- III. Domicile certificate issued by the Competent Authority.
- IV. Health Certificate from the concerned District Chief Medical Officer.
- V. Valid relevant category certificate issued by the competent Authority.

The appointment of the above candidates shall be further subject to the following conditions: -

- a. Each appointee(s) shall give an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification/Date of Birth/other certificates from the concerned issuing authorities is found fake/forged, his appointment shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.
- b. That if the appointee(s) has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the

Domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government Services. He/she shall be required to liquidate the entire loan liability in suitable EMIs to be worked out by the DDO concerned from their salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any in such a self employment unit/enterprise and recovery to be made, and, thereafter, ensure the recovery.

- c. The salary of the appointee shall not be drawn and disbursed to him/her unless satisfactory report in respect of genuineness of their qualification certificate/Date of birth/ other certificates is received from the concerned issuing authority. In case during the course of verification, any of the documents turn out to be fake/forged, the appointment shall be cancelled ab-initio and appropriate criminal proceedings against him/her shall be initiated accordingly.
- d. The inter-se-seniority of the appointees shall be determined in accordance with the merit secured by them in the selection list prepared by the Services Selection Board and in terms of J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- e. The appointee shall be governed by the “New Pension Scheme” as notified vide SRO-400 of 2009 dated. 24.12.2009.
- f. The appointee shall be on probation for a period of two years in terms of Rule 20 of J&K Civil Services (CCA) Rules, 1956.

g. The appointment shall be subject to outcome of OA/1799/2025 (JAMMU) titled Naair Amir Bhat V/s PW (R&B) & OA 49/2025 (Jammu) titled Ankit Raina V/s PW (R&B) Department, and any other writ petition(s), if any, pending before any competent Court of Law.
