- (i) The placement shall not confer any preferential claim or right to the officer for seeking regularization/confirmation, which shall be considered strictly as per rules by DPC/JKPSC.
- (ii) The placement shall be subject to the outcome of writ petition(s), if any, pending before any competent Court(s) of law.
- (iii) The Officers shall submit an undertaking to the concerned CEO stating therein that in case his/her service particulars/academic credentials are found fake/forged/tampered or issued by an unrecognized University, his/her placement shall be deemed to have been cancelled ab-initio.
- (iv) In case of an adverse report against any officer regarding the Work & Conduct and Integrity, his/her placement shall be deemed to have been cancelled, ab-initio.
- (v) The assignment is purely temporary, and in academic interest and in the interest of administration.
- (vi) The officers shall report to the concerned Chief Education Officer(s) within 10 days from the date of issuance of this order and in case of failure to join within the stipulated period, his/her placement shall be deemed to have been cancelled ab-initio without any further notice.
